  - "You may also ask the court to appoint a lawyer for you. But remember that, unlike in a criminal case, you do not have a right to court-appointed counsel in a civil case, appointment is reserved for extraordinary circumstances, and a lawyer is not required to accept an appointment. To make your request, you must file a motion for appointment of counsel."
- 2. Given the gravity of the matters described, verified (via sworn affidavit) and documented (by various court filings and more), there are certainly extraordinary circumstances that warrant this court's assignment of court-appointed counsel.
- Local Rule 2.05 (APPEARANCE BY LAW STUDENTS) and Fla. Bar Rule Rule
   4-6.1 (Pro Bono Appointments in Civil Cases) give some possible remedies which might be

appropriate to assure that indigent litigants may proceed—and get a fair day in court—and address very serious—institutional and chronic—violations of civil rights by certain state courts so enumerated in this complaint. Plaintiffs consent to "entry of an order by the Court directing payment of all non-prepaid fees and costs out of any recovery, including a reasonable attorney's fee if counsel has been appointed by the Court to represent such person," as delineated by Local Rule 4.07(b) and Local Rule 6.01(c)(4), governing IN FORMA PAUPERIS PROCEEDINGS and DUTIES OF UNITED STATES MAGISTRATE JUDGES, respectively.

5. Lead plaintiff is smart, but he is only 1 indigent person, and not a lawyer—and feels it is inappropriate to "take chances" by putting all your eggs on 1 basket—even his.
