But to see my *full* resume, see my staff entry under my father's entry, and, for the record, I give a "split endorsement" to you and James Judge, your other GOP primary opponent. I know you'd prefer a full endorsement, but I must be an honest Christian first and then a political partisan: unless or until I hear otherwise, the differences you two have are "*de minimus*," a legal term with which you are familiar.

Maybe Lee ought to consider, maybe, obeying the GOP Platform, here, and at least trying to cut prohibited liberal pork student loan originations spending – if she wants my endorsement, but I doubt she will do the right thing: Even when we held a majority with a GOP House, Senate, & held the oval office twice in recent decades, GOP lawmakers didn't try to cut this pork, so, my estimation is that we'll crash the dollar and/or incur hyperinflation unless either an unlikely miracle intervenes (unlikely) or collegiate debt bankruptcy is first reinstated, like it was in our grandparents' time, so it would – once again – operate as a Conservative Free Market "check/balance" on excessive lending/spending by Dept. of Ed – and (more-importantly) send a message to lobbyists to "back off" & see the "handwriting on the wall," so weak lawmakers (like Lee) will do the right thing. She seems unlikely to support either bankruptcy uniformity (see US Constitution Art.I, Sec.8, cl.4) or cuts to liberal pork spending, so I see it unlikely she'll get my endorsement. Just saying.
