

This document shows that Assistant State Attorney, Peter K. Mislovic, swears under oath that his prosecution here is in 'good faith,' and that may be; however, if it is in good faith, it shows he was negligent and did not review the record. If however, he had reviewed the record, it would have shown that the police report, written by Ofr. Leanne Yeager #179, and Ofr. Dennis Mosser #291, was clearly false, perjured testimony, as the dispatcher never said to "not go into the area," as claimed by these 2 officers. Notice also that there was a charge of resisting arrest against Ofr. Yeager. Since I clearly remember telling her (and several other officers who interviewed me) that I did not knowingly interfere with a police investigation, this may be the basis for the resisting charge. However, I was correct in telling these officers I was innocent: Even the police admit they were hiding from plain view, and therefore there's no way I could have seen them, thus I did not knowingly interfere with them as claimed. OF NOTE: Even after I insisted I had no knowledge of a purported investigation, Ofrs. Yeager & Mosser made a false report -which was reviewed & approved by supervisors, who were therefore also bear responsibility (read: guilt).
